- For filming, photography & documentaries permits are issued subject to the condition that prior permission in writing be secured from the owners or responsible holders of all sites and government authorities
- Locations and properties on which filming take place further, need to acquire all necessary permits from the shooting locations.
- All foreign nationals should apply for a business visa before arriving Maldives.
- This form and responsible letter should be signed by a Maldivian.
- For drone's operation in the Maldives, authorization will be issued from Ministry of Defense and National Security. (This permit should be included with your application for film shooting)
